If you cannot make your scheduled match for the week, you may shoot at an away range during the same match week and not have the match count as a make-up. (This means that you can't shoot on your home range and use this rule.)

MAKE-Ups: Total of 3 per shooter. Three make-ups may be used for team score if they are fired before or during the same week of the match missed. These may be fired at any match, home or away. For rare exception contact Andrew Whiting @ 515-570-3180 or Mike Gimer @ 515-571-3359.

The Host Team will wait until 7 PM, if the guest team has not arrived, before shooting. The guest team will be allowed first access to the firing points. Unless prior arrangements are made with Host Team's Captain, shooters arriving after 9 p.m. may not be allowed to fire.

The Rifle and Pistol Club of Fort Dodge was established in 1959 and maintains shooting ranges for member's use. The indoor range is located in the basement of 300 S 13th Street, Fort Dodge. It offers ten firing stations at a range of fifty feet.

The club sells firearms, ammunition and reloading components to members at a discounted price. **Members must have a valid annual permit to purchase or permit to carry issued by their local sheriffs department and show it to the Quartermaster to purchase firearms or ammunition from the Club Store.** Monthly Club meetings are held on the second Thursday of each month and a newsletter is published monthly to keep members informed of events.

Membership dues are \$120 per year. Senior memberships are \$80. Spouse Membership \$30 (for League Participation and or individual keys for spouse). **Membership in the National Rifle Association is required.** The Rifle & Pistol Club of Fort Dodge is incorporated under the laws of the State of Iowa.

RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT for Member

WHEREAS, in consideration of being granted membership, for use of premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Undersigned agrees to the following:

Undersigned agrees to indemnify, hold harmless and defend the Rifle & Pistol Club of Fort Dodge Inc., its officers and directors (hereinafter referred to as "the Club") from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: Undersigned's presence at and/or participation in all club activities; the discharge of firearms by Undersigned; Undersigned's presence on or the use of the ranges, buildings, land and premises; and any and all acts or omissions of Undersigned.

Undersigned furthermore waives for himself/herself and for his/her executors, personal representatives, administrators, assignees, heirs, and next of kin, any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he/she may have or which may arise against the club (including but not limited to the death of Undersigned and/or any and all injuries, damages or illnesses suffered by Undersigned or Undersigned's property), which may in any way whatsoever, arise out of, be related to or be connected with any activities, the Premises, including any latent defect in the Premises; Undersigned's presence on or use of said Premises; Undersigned's property and, the discharge of firearms. The club shall not be liable for, and Undersigned, on behalf of himself/herself and on the behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases the Club from any and all such claims and liabilities.

Undersigned hereby expressly assumes the risk of taking part in the activities on the Premises, which include, but are not limited to, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition.

Undersigned also assumes responsibility for any person he/she brings with them to Club facilities and will ensure that they also abide by all club rules and that the club member must be present with any guest at all times that they are on Club Premises. Non-members must sign a release form before they are allowed to participate in activity on Club Premises.

Undersigned hereby acknowledges and agrees the Undersigned has read this instrument and understands its terms and is executing this instrument voluntarily: Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and procedures posted by the Club.

Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by the Club shall not constitute any waiver of the Club's right to Pursue other available remedies. This instruments binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.
